*Waupaca Rails 2008* was held at the Best Western Grand Seasons Hotel in Waupaca, Wisconsin on May 9, 10 & 11, 2008. From all reports the 89 attendees had a great time.

The first event was a tour of the ThyssenKrupp Waupaca Foundry Plant 1. About 50 convention participants went on the tour. The tour started with an overview of foundry operations and a safety briefing. After reviewing and signing a safety protocol, each participant received a hard hat, safety glasses, earplugs and an "overcoat" for the tour. Groups of three or four were then guided through the plant by TK Waupaca employees where the melt department, core room, pattern area, molding machines, finishing area and warehouse/shipping areas were viewed. After returning from a very informative and enjoyable tour, no one wondered about the plant's emphasis on safety!

Friday evening featured operating sessions and three clinics: "DM&IR Cabooses" by Mike Kirk; "I Installed DCC, Now What?" by Paul Pasowitz and Fallen Flags by Gary Children. Saturday morning clinics included "Model Photography Techniques" by Rich Hanke; "Researching the Prototype" by David Leider; "Operations Along the Soo" by Mark Preussler; "Bootlebrush Trees/Ponderosa Trees" by Chic Hartert; C&NW LP (Bulkhead Pulp) Flatcars" by Rich Hanke; "A View from the Bridge" by Capt. Al Nelson; "The Roy Campbell Photograph Collection" by Tom Burg and "Industrial Archeology: The Milwaukee Beer Line" By Richard Cecil.

Saturday afternoon layout tours were west of Waupaca and included Mike & Mary Eiden's Miladore Rudolph & Eastern and Custer Central; Don Kottke's Big Northern Railroad; Pat Lyons "Q" RR; Larry Misiewicz's Golden Sands Southern; Gordy Sauve's two-story (!) three-rail O gauge pike; Roger Hildebrandt's Evergreen Hills & Allen Creek

and Arpad Eiler's Great Freedom RR. The Waupaca Soo Line depot, which is being restored, was also open.

Sunday afternoon layout tours were east of Waupaca and included Eugene Much's Little Wolf Central; David Johnson's Der Bahnhof; John Poris' Johnstown Roseville & Western; Wilard Wilde's Lind Center & Southern; Lynn Draper's Fremont & South Park; Pat Smith's Cajon Pass; Randy & Dayna Williamson's Pennsylvania & Deer Creek Lumber and John Franzen's Milwaukee waterfront & Mexican mining layouts. With eight tours on each day, attendees could visit each layout and the depot in the allotted time.

Participation in the model and photo contests was strong. There were 22 entries in nine model contest categories and 47 entries in the photo contest. A family-style banquet, the annual meeting of members, model & photo contest awards and the auction capped Saturday's activities. The Spring Board of Directors meeting was held Sunday morning. .

For the year then ended revenues, primarily from *Waybill* subscriptions and the NMRA dues rebate, were \$9,713.71; expenses, primarily for the *Waybill*, were \$3,266.21 and net revenue was \$6,447.50.

Gary Children presented a plaque to Bob Sherman in recognition of his service as Region Treasurer.

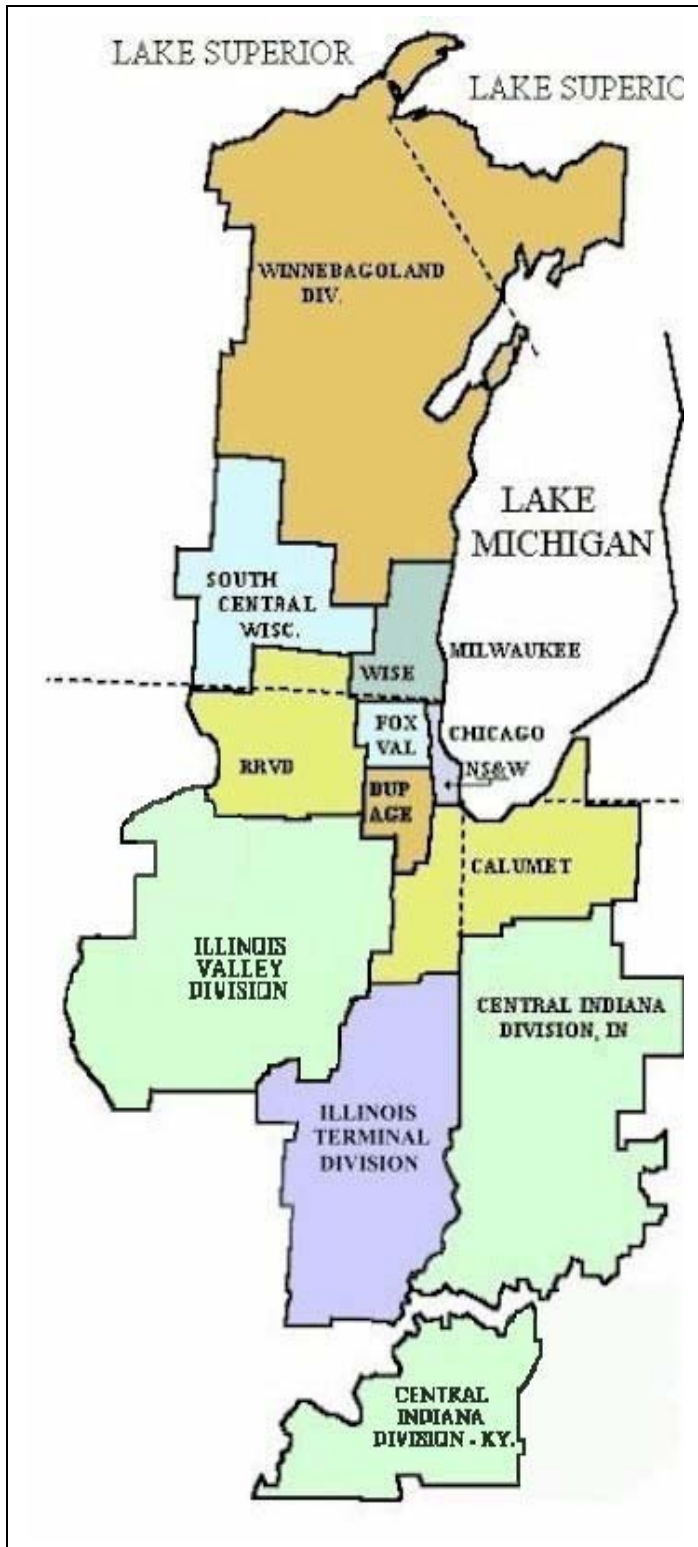

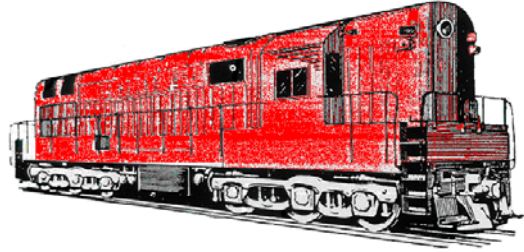


Two clinics, contests, and a general good time, was followed by a tour of four SCWD layouts.

# 2009 Election

## Petition Deadline Is August 21, 2008

Although the 2009 election is several months away, it is time to start the election cycle. In 2009 we will elect a President, a Vice President and three (3) Directors-at-Large.

In 2009 Gary Children and Randy Williamson will both complete second two-year terms as President and Vice-President, respectively. Under the Bylaws, Gary will become the Immediate Past President and Randy will not be eligible to run for another term in 2009. Thanks to Gary and Randy for their dedicated service.

In 2009 Bill Litkenhous from the Central Indiana Division, one of the three incumbent DALs, will complete his second two-year term. Bill will not be eligible to run for another term in 2009. Thanks to Bill for his dedicated service. Chris Roeben from the South Central Wisconsin Division and Jim Wise from the Illinois Valley Division will complete their first two-year terms and will be eligible to run for another term in 2009.

There are two ways that your name can be placed on the ballot. The first is by recommendation of the Nominating Committee and approval of the Board of Directors. To be considered by the Nominating Committee (Chairman Jim Spice from the North Shore & Western Division and Members Reid Kahrs from the Wisconsin Southeastern Division and Jim Osborn from the Fox Valley Division), you must submit a biography/candidate's statement of 200 words or less and a 2x2, passport-style photo to the Committee with a copy to the Region Secretary (Bert

Lattan) as soon as possible, but no later than August 21, 2008.

The preferred method of delivery is electronic mail. (While e-mail is not required to serve on the Board, it is highly desirable since the Board conducts pre and post meeting activity by e-mail.) If you do not have e-mail, you may mail your bio/photo to Bert Lattan, who will convert it to an electronic format and send it to the Committee. Addresses and e-mail addresses for the Committee and the Secretary are on the Region website ([www.mwr-nmra.org](http://www.mwr-nmra.org)).

The second method is by petition signed by at least ten (10) current, resident NMRA members. The petition form is available on the Region website or it may be requested from Bert Lattan. Your petition must be accompanied by a biography/candidate's statement of 200 words or less and a 2x2, passport-style photo. It must be received by Bert Lattan no later than August 21, 2008. He will convert it to an electronic format and forward it to the Committee.

The Committee will submit its recommendations and the names of all resident members nominated by petition to the Board of Directors for review and approval during its next meeting. That meeting will be held on Sunday, October 5, 2008 in Downers Grove, Illinois.

Each candidate's biography/statement & photo and a ballot will be included in the Winter 2008 issue of the *Waybill*. The results of the election will be announced during the 2009 Annual Meeting of Members. The meeting will be held during the Spring 2009 Convention, which is scheduled for April 17-19, 2009 at the Clock Tower Resort in Rockford, Illinois.

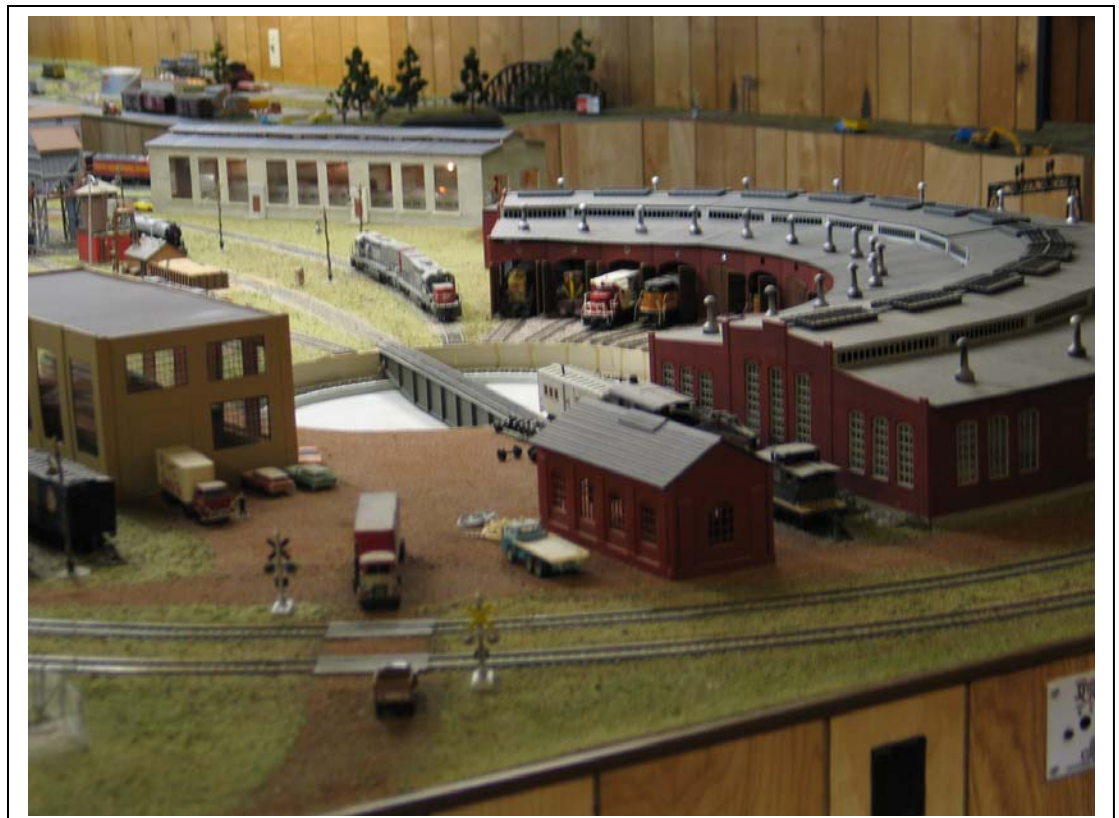
